GCOS Activities in 2024

The 2022 GCOS Implementation Plan, adopted by UNFCCC, WMO Congress and IOC General Assembly, provides a list of actions necessary to improve and develop the system of global climate observations. Some of the actions need to be performed by the GCOS panels supported by the GCOS Secretariat or by the GCOS secretariat itself.

GCOS secretariat workplan:

- follows from the GCOS IP actions (many already started in 2023)
- includes other activities which are the continuation of other relevant initiatives that run in 2023
- includes a third type of activities that are intrinsic part of GCOS programme's operation such as outreach and communication, liaison with GCOS partners and sponsors, and support to GCOS networks.


